
Statement of Policy on Discrimination

Administrative Policies and Procedures

<u>Tardiness</u>

The student must be in the classroom at the schedule time. Students who are up to 10 minutes late may enter the classroom.

F-1 Students

SEVP requires that students who want to maintain status as F-1 students attend a minimum of 18 hours per week. For an absence to be justified, students must provide a doctor's note, court appearance summons, a police report, or an immigration appointment. In addition, leaving school early without requesting permission and showing proper justification will be considered a violation of the attendance policy.

Early Withdrawal

Rules and penalties for early withdrawal will be provided to you in your orientation by your DSO/PDSO.

Admission Requirements

Enter during Weeks 1 or 9 of the Term.

Registration

New students will register for classes and pay for tuition before orientation, and they will not be able to register or attend classes until they have paid in full.

IES Student Complaint Policy

A student complaint can be defined as a concern that a policy or procedure has been incorrectly or unfairly applied in his/her particular case or a formal charge against a person's behavior.

Informal Complaint Process

A student with a complaint has recourse through complaint procedures. In most instances, complaints can be resolved through an informal process, beginning with talking to the individual and his/her instructor if necessary.

Basic steps in the informal process include: Discussing the matter with the staff member, instructor, or department in which the issue originated.

Formal Complaint Process:

If the issue is still unresolved after following the appropriate informal complaint procedures, the student may choose to have the issue "officially documented." The student must complete the "Student Complaint Form." That fulfilled form will be forwarded to the e staff member, instructor, or department in which the issue originated.

Transferring to/from another institution

For transfer from another institution: Required Documentation

- A Valid Student and dependents' Passport;
- Student and dependents' F1 or B1/B2 visa:
- Bank statements proving funds: \$14,000.00 to the Student F1 \$4,800.00 to each dependent F2

- Current F1 (student) and F2 (dependents) I-20;
- F1 Marriage Certificate and F2 Birth certificate;
- Filled and signed Sponsor letter in dollar currency;
- Sponsor ID, phone number, address and a valid email.

For transfer to another institution, the student must notify the school 15 days in advance using the appropriate form found at the office, and to pay the contractual fees.

Tuition Refund Policy

Overview. Students who reduce their course load by officially dropping or withdrawing from a class or classes will have the tuition refund cancellation calculated as of the date of the official course drop. Discontinuing attendance from class or notifying an instructor does not constitute an official course drop. Without an official course drop, students will be responsible for all tuition and related fees. Students should check the Academic Calendar for the specific course drop dates for each semester. The student's account must show a credit balance before a refund is processed.

B. Tuition Refund Schedule for Courses within a Regular Semester. When students withdraw from courses within a regular



semester, refunds will be based on the published dates in the Academic Calendar ISL Ideal English Schools.

The cancellation percentage is based on the date of the official course drop or withdrawal:

- 100 percent tuition refund for course drop/withdrawal through the second calendar week of classes
- 50 percent tuition refund for course drop/withdrawal through the third calendar week of classes
- 25 percent tuition refund for course drop/withdrawal through the fourth calendar week of classes
- No refunds for course drop/withdrawal after the fourth calendar week of classes.
- C. Tuition Refund Schedule for Courses Outside of the Regular Semester Academic Calendar. Courses held outside of the regular semester academic calendar. In addition, tuition and fee refund policies and deadlines for study abroad programs may differ by program and location. Students in these courses should check with the appropriate office or program webpage for specific guidelines.
- D. Tuition Refund for Online Courses within the Regular Academic Calendar, all students enrolled online course except for international students, who don't qualify for online course are exempt from this policy and

all other student will forfeit their registration fees and the first tuition payment.

E. International Students:

Tuition: The tuition is \$_____ for all F1 students, which means that international students generate revenue for ISL Ideal English Schools.

Tuition Refund Policy: If a student is unable to get the F-1 Visa, the full amount of the tuition will be refunded, however the registration is non-refundable. If a student begins school, then transfers or terminates prior to the end of 1st semester, tuition will not be refunded for the current semester. If the student transfers or terminates after the first semester, without attending any day of the second semester, the tuition amount for the second semester will be refunded. Refunds will be paid only to the remitter of the wire transfer, credit card, cash receipt on the receipt for payment.



Applications are accepted every two months from academic calendar. Sufficient time should be allowed to complete the application, obtain the I-20, attend the visa interview at the U.S. Consulate and travel to the U.S. prior to school start date.

F. Refund Payments Schedules:

All students' refunds will be processed within five business days after the completion and review of the student's withdrawal from the semester, and withdrawal or transfer documents have been completed and signed off by the Academic Administrator and final approval of the Chief Financial Officer.

Enrollment Agreement

When the student decides to register at Ideal English School they are given an enrollment agreement which includes all the information about the program type, frequency, start date, fees, terms and conditions.

Payment Policy and Procedures

According to school policy, the student is committed to paying the current month's tuition with the due date scheduled for the first day of the month. However, the student has until the third day of the month to pay the current month's tuition without fines. This period is considered by the school as a "grace period" for possible unforeseen events.

Late Fee: If no payment is made after the third day, IES will apply 10% to the student monthly tuition as a late fine.

Financial Warnings: If no formal agreement is made by email or in person for students who are in arrears during the current month's tuition, IES will issue a financial warning on the 6th day.

If the student resumes payment, IES will not remove the warning record and the student has a maximum limit of up to 3 warnings within the term agreed in their contract.

Cancellation of I-20: IES reserves the right to cancel an I-20 after 4 financial warnings or a monthly payment more than 15 days late without a formal agreement between both parties.

The school provides students with the possibility of making payments through Zelle, Credit/Debit Card, Cash and Wire Transfer. The student will have access to the school's financial platform and be able to view their account. Payment reminders will be issued to students: 3 days before payment is due, 1 day, and on the due date itself

Academic Policies and procedures

Instructional Methods

The Ideal English School methodology is based on conversation. The school has a technical and academic structure to develop

mainly speaking skills. The focus of instruction is on comprehension and meaningful communication and puts less emphasis on grammar, teacher monologues, direct repetition, and accuracy to develop communicative skills.

The method claims that new language learning is a reproduction of the way humans naturally acquire their native language. The language output is not forced but allowed to emerge after students have attended to large amounts of comprehensible language input. That minimizes student's anxiety and maximizes student self-confidence.

Students acquire the target language in a natural way, from easy to difficult, and from concrete to abstract. They are going through four stages:

- Preproduction (listening and gestures);
- Early production (short phrases);
- Speech emergence (long phrases and


sentences);

• Intermediate fluency.

Initial Placement

The Ideal English Schools administers an initial placement exam which aims to place students at the appropriate level contributing to a successful learning experience. The test was developed by Cambridge, and contains oral, listening and writing quizzes. The results are kept with the students files.

Counseling

To assist us in maximizing student satisfaction and placement accuracy, you will have a counseling session with the Academic Coordinator/Director at the end of your first week of study. If you have any concerns about your level, make sure you let them know during counseling. A change of level request form must be filled out in case you think you may not have been placed at the right level. You may request any additional counseling sessions anytime you deemed necessary.

Level Change Request

If the student feels misplaced, within the first week, they may request a Change of Level form. The academic coordinator will consult with the faculty member and verify via student data and faculty recommendation that the student may be moved.

Grading Procedures

Students are assessed based on the level of their progress of the student learning outcomes illustrated in their course syllabi. Students who fail to achieve satisfactory progress (at least 70%) will receive a notice of probation. Students who do not complete assessments must make those up within two weeks of the exam date with their teacher or coordinator.

Grades may be accessed throughout the term via the LMS. Depending on the course, students may have listening/speaking assessments alongside their unit exams in the text.

Student Progress

Progress may be accessed at any point during the term via the LMS. Students experiencing academic difficulties have a variety of options include tutoring, counseling, and academic accommodations.

Academic Probation/Failing

Students who fail a course will receive academic probation for the following term. After completing a counseling session, students may repeat the level during the next term. A second failure constitutes a written academic warning followed by a counseling session with the Academic Director, and students are in danger of termination.

Students receiving a third notice may be terminated. Rare instances approved or denied_on a case-by-case basis by the program's Academic Director may be deemed exemptions, for example, medical reasons.

Certificates of Completion

Ideal English Schools will provide all students a certificate of completion at the end of each

module if the student has successfully passed the module.

Vacation

F1 students with a one year I-20 will have up to 16 weeks of vacation.

An annual vacation is an authorized break in a student's studies that is taken once per academic year and lasts one term. F-1 students are eligible to take an annual vacation after completing their academic year requirement at a Student and Exchange Visitor Program (SEVP)-certified school and once every year after that. Although it is most

frequently taken during the summer term, it can be taken during another academic term, which is usually determined by a student's school calendar.

All vacation requests are approved according to the following:

- Students must request a vacation 3
 weeks in advance, and the vacation
 must be approved at least one week
 before the vacation start date. It is the
 student's responsibility to confirm
 with the front desk the status of the
 vacation request.
- In order for a vacation to be approved, students cannot be on probation.
- All payment due to the school must be made prior to leaving for vacation.
- Untaken vacation time may not be accumulated or may not be carried over to the next week term cycle.
- As any policy, this policy is subject to change in the event of new regulations affecting this issue.
- Any student with a need to take a religious holiday may speak to the school representatives/DSOs for help in this matter

Attendance Policy and Procedures

Students will be marked tardy if they miss more than 15 minutes of class, or absent if they miss a total of 1 hour across two class sessions or the equivalent of 30 minutes per class session in a single day. Three tardies equal one absence.



For students attending class twice a week, missing a full day counts as two absences. A maximum of two unexcused absences per week is permitted. Attendance will be monitored throughout each 16-week term, and students accumulating more than 12 unexcused absences will receive a disciplinary notice. Absences may only be excused with a valid written note (e.g., a doctor's note). If a pattern of unjustified absences or frequent tardiness is identified, the student will face appropriate disciplinary action.

Attendance Probation

Students who fail (or receive a grade comment "Insufficient Assessment") will receive academic probation. During the next term, students will either receive remediation, repeat the level, or be re-placed into the program. Students receiving a third notice may be terminated.

Surveys

Every term you will be asked to fill out the end of course survey. It is very important to us that you fill it out so we can collect your feedback and improve the quality of instruction and services provided by IES.


Events


